MOTA-ENGIL WON CONTRACTS AMOUNTING TO €713 MILLION

Mota-Engil S.G.P.S., S.A. (“Mota-Engil”) informs that it was awarded several contracts in Africa, Latin America and Portugal amounting to €713 million, of which around 68% with private clients, including the Brazilian company Vale, with whom Mota-Engil established contracts valued at €333 million.

In Africa, Mota-Engil won contracts in six markets in the infrastructure segment comprising different technical expertises, totalling €565 million. These awards reinforce the Group’s backlog in markets such as Angola, Mozambique and Malawi, and helps to consolidate the market position in markets such as South Africa, São Tomé and Príncipe and Rwanda, with the latter representing a new market for the Group, in line with its expansion and diversification strategy.

Accordingly, the contract awards were in the following countries:

- Angola: roads infrastructures and civil construction amounting to €115 million;
- Malawi: roads and railway infrastructures totalling €109 million;
- Mozambique: roads and railway infrastructures, mining exploration related works, and maintenance and emergency works in Nacala’s Corridor that also spins to Malawi territory, all amounting to €233 million;
- São Tomé and Príncipe: construction of a touristic resort and water infrastructures totalling €13 million;
- South Africa: civil construction, namely a hospital and apartments totalling €69 million;
- Rwanda: expansion works in the Kigali’s International Airport amounting to €26 million.

In addition, in Latin America, Mota-Engil, was awarded, through its subsidiary Empresa Construtora Brasil (“ECB”), a contract amounting to R\$380 million (€117 million). The contract awarded by the Brazilian company Vale comprises infrastructure works and the duplication of the railway Ferro de Carajás in an extension of 40 kilometers in Maranhão State. Works are expected to be completed within 21 months.

In Portugal, Mota-Engil also won contracts, mainly related to one road infrastructure and civil construction, amounting to €30 million.

With these awards Mota-Engil added €713 million to its backlog.
